

**DEPARTMENT OF FOR-HIRE VEHICLES (DFHV)
NOTICE OF FUNDING AVAILABILITY (NOFA)
FY22 CAREER AND TECHNICAL EDUCATION - TRANSPORTATION SERVICES**

The Government of the District of Columbia, Department of For-Hire Vehicles (“DFHV”), is soliciting applications from all eligible DFHV licensed taxicab companies (“Taxicab Companies”), and transportation network companies (“TNCs”), with current Digital Taxicab Solution (“DTS”) or Digital Dispatch Services (“DDS”) DFHV licensing and Operational Authority to operate DFHV’s Career and Technical Education – Transportation Services (“CTETS”) Pilot program. The CTETS Pilot program is envisioned to provide a “shared riding” mobility point-to-point solution to transport children to and from selected schools throughout the District of Columbia. Eligible entities must have a DFHV operating authority approval to apply. DFHV’s RFA No.: CTETS 2022-18-7 announcement is seeking for-hire companies that have previous youth transportation service experience within the District of Columbia. This announcement is to provide public notice of the Department of For-Hire Vehicle’s intent to make funds available for the purpose described herein. The applicable Request for Applications (“RFA”) will be released under a separate announcement with guidelines for submitting the application, review criteria and DFHV terms and conditions for applying for and receiving funding. Start date for this project is: August 29, 2022 and into Fiscal Year (FY) 2023 (October 1, 2022 – September 30, 2023).

Program Description:	The FY22 announcement of the CTETS Pilot RFA seeks to implement a cost-effective, high-quality transportation service offering designated pick-up location and/or drop-off location (i.e.: customers’ respective school/Trinity Washington University, which is the hub the CTETS pilot). Routes may be modified depending on customer and school institutional needs, construction, traffic incidents/crashes, etc. The FY22 Career and Technical
