Program Description:	The Government of the District of Columbia, Department of For-Hire Vehicles ("DFHV") seeks to Provide a costeffective, high-quality transportation services to eligible DC residents, on behalf of Fire and Emergency Medical Services, with or without disabilities needing transportation to and from community based medical providers for situations that do not involve an immediate threat to the life or health of the customer.
